Previous Minutes

VP Officiating Report

1. Provincial RICs

VP Coaching Report

1. Upcoming Clinics

Rick Phillips told the Board that there are 3 more coaching clinics coming up the May 22nd weekend in Orangeville, Kingston and Sudbury.

2. Database

Rick inquired about Ontario starting its own database of each coach's status/training is. It was discussed but the task would be too tough to maintain.

VP Promotion Report

1. Golf Tournament

Mary Sticca told the Board that the golf flyers have been printed off and will be mailed out soon.

VP Development

1. Novice Team Ontario Camp

Wendy Cuthbert told the Board that there were 87 kids who registered for the camp and only 55 showed up. She mentioned that it ran great. All of the kids got to keep their jersey and a certificate which most got the instructors to sign by the pros running the camp.

2. Junior Field Team

Wendy told the Board that the Junior Field Team Ontario try out was rained out. She is trying to get some of the money back for that.

3. Online Registration

Wendy mentioned that there will be online registration for Team Ontario next year.

4. Team Ontario Warrior & Gait

Wendy told the Board that Warrior and Gait have agreed to allow Team Ontario to use equipment from both companies. This should ensure that all teams have the desired equipment they need for field and box.

5. Midget Nationals

Wendy asked John what the procedure is to request longer breaks between periods at the Midget Nationals. She mentioned that the periods are 17 minutes long with only a 3 minute break. Games that have 20 minute period receive 10 minute breaks. John said that it may be too late to submit this to the CLA for the semi-annual but that if all MAs approve of the change it could be done.

6. Terri-Lynn Dixon Suspension

Wendy told the Board that Stephanie Simpson has received some information from Terri-Lynn. Stephanie and Wendy still need to go through the documents to make sure they have everything they need. The Board will uphold the suspension until they receive notice from the Women's Box Council that everything is in order. The suspension carries across all aspects of Ontario Lacrosse including things like Coaching Clinics.

VP Field Report

1. Coaching Clinics
